
HP DesignJet Cash In & Trade Up July-September 2026 Promotion



Terms

A. HP DesignJet Cash In & Trade Up July-September 2026 program structure

- Within the framework of the HP DesignJet Cash In & Trade Up July-September 2026 program, “Participants” (as defined below) may claim cash back awards by purchasing “HP Products” (as defined below) and submitting a claim in accordance with the following terms.
- The HP DesignJet Cash In & Trade Up July-September 2026 program is referred to in the following terms as the “Program”.

Participants

- HP U.S. Authorized Reseller who has an established HP partner agreement and who is authorized by the HP Qualified Distribution Network are referred to in these terms as the “Reseller”.
- End-user Customers and Resellers are allowed to participate in this Program, claim and receive any cash back award.
- The company claiming and entitled to receive the cash back award is referred to in these terms as the “Participant”.

HP Products and Trade-in Products

- The list of qualifying new HP products can be found in “Section D” of this document, and are referred to as “HP Products”.
- The eligible Trade-in Products can be found in “Section D” of this document, and are referred to as “Trade-in Products”.
- HP Products and Trade-in Products are eligible to be claimed only one time.
- This promotion is a one-for-one trade only, one HP Product for one Trade-in Product.
- The Program is valid for transactional sales of HP Products and for HP Products which are leased or deployed on a contractual basis to a third party, including Facilities Managed placement arrangements.
- Only new HP Products and reseller demo products purchased within nine (9) months from authorized HP Distribution are eligible to take part in the Program.
- The promotion is not valid on refurbished printers, printers purchased /leased through internet auctions, or from any other unauthorized reseller of HP products.
- HP Products must be purchased from Reseller or HP (as defined below).

Promotional Period

- The Program is valid between July 1, 2026 and September 30, 2026.

Promoter

HP Inc. (referred to herein as “HP”).

Program steps and timing

The Participant can obtain information about and register for the Program on the website hp.com/go/cashin2.

1. **Purchase:** Purchase/lease, or contractually deploy a qualifying new HP Product within the defined promotional period. Each claim must have a corresponding approved trade-in unit to receive the eligible rebate amount. Rebate values are determined by the new printer purchased or leased. See the chart in “Qualifying new HP products and Eligible Trade-in Products” section below for rebate and trade-in product details.
2. **Claim form:** All claims must be submitted online at: hp.com/go/cashin2. Complete and submit the online claim form by October 31, 2026. You must upload your proof of purchase (as defined below) at the time of claim submittal. Any claims received after this date will be rejected. After you submit your online claim, 360insights will send a confirmation email upon review of the claim number and other information related to your claim. Please print and save these for your records. Reference this claim number for questions relating to this promotion.
3. **Proof of purchase:** A copy of your sales invoice/s (lease or contractual deployment documents) showing eligible purchase of an HP Product.

The Proof of purchase must contain the following information:

- Name and address of the end-user customer.
- Name and address of the HP reseller, in accordance with the statement on the letterhead; and,
- Model, SKU, serial number, and the purchase price of the HP Product.
- Make, model, and serial number of Traded-in Product.
- If the rebate is being passed on to the end-user customer upfront by the HP Reseller, the end-user customer invoice must show a line-item detailing the Cash In & Trade Up rebate amount being deducted from the printer price to arrive at the net printer price.
- If further review is necessary, HP reserves the right to request the distributor invoice to ensure that the order was placed on behalf of the end-user customer within the promotional purchase period.
- If the serial number(s) of your eligible new HP Product(s) is not listed on your proof of purchase(s), please write the serial number(s) of your eligible HP Product(s) on the document prior to submitting.

You must supply the serial number and make/model of the eligible trade-in product and purchased product during this claiming step as part of the proof of purchase.

Keep a copy of your entire claim for your records.

Important note: Last day to submit a claim and proof of purchase is October 31, 2026. Each claim must be accompanied by proof of purchase. Failure to attach will result in claim rejection.

4. **Recycling trade-in product:** You may recycle your eligible trade-in, large-format printer through HP by visiting <https://bit.ly/4ao3NQe> or discussing recycling options with your HP U.S. Authorized Reseller.
5. **Cash back¹:** Please allow eight (8) weeks from receiving the claim completion email for receipt of your cash back payment. For questions regarding the status of your submission, please email hprebatesupport@email-360insights.com.

Trade-in Products

- The Trade-in Product(s) must be located in the U.S.
- Trade-in Product(s) must be able to be powered on. The Trade-in Product(s) must be complete and in good working condition. "Complete" means that the Trade-in Product(s) will include, at a minimum, all hardware, software, and component parts and copies of all applicable license(s) needed for the Trade-in Product(s) to operate. "Powered on" means that, at a minimum, all parts of the Trade-in Product(s) can be turned on.
- The Trade-in Product(s) must be recycled, scrapped, or otherwise disabled by an HP U.S. Authorized Reseller or the end-user customer.

B. Disclaimers

End-user Customer transactional sales

- The End-user customer may submit a claim as a Participant in this program. This is only valid if and when the cash back is not awarded upfront by the Reseller to the End-user Customer on the proof of purchase.

Reseller involvement

- The Reseller may submit claims on behalf of their end-user customer by following the same claim process outlined above.
- The Reseller must pass on the full cash back amount to the customer first, and clearly indicate on the proof of purchase that the credit has been given to the customer.
- HP will not compensate Resellers for discounts that exceed the promotion cash back allowance.
- HP Cash In & Trade Up July-September 2026 promotion is an end-user customer trade-in promotion.
- Participation in the HP Cash In & Trade Up July-September 2026 promotion indicates that end-user customer agrees that its Reseller, and not HP, is solely responsible for any negotiated sums exceeding HP's authorized trade-in values.
- Reseller may not substitute other Trade-in Product(s), or submit a Trade-in Product(s) serial number not owned by end-user customer.
- If the printer rebate is being passed on to end-user customers, upfront by Reseller, end-user customer's proof of purchase must show a line item detailing the Cash In & Trade Up rebate amount being deducted from the printer price to arrive at the net printer price.

Leased or contractually placed product

This promotion is valid only in the US and available for new lease/contractual agreements entered into between a Reseller and End-User Customer if the following conditions are met:

- The new lease/contractual agreement must be for at least a one-(1) year term, and the newly leased/contractual unit must replace an older eligible product (HP or Non-HP) that is being removed from service.
- The proof of purchase submitted with the claim must list the leasing/contractual services of the item being placed (e.g. for lease of an HP Product XXX applicable from (date) through [date]).
- Both the new lease/contractual HP Product and the Trade-in Product(s) must be eligible product(s).
- The Reseller must pass on the full cash back amount to the customer first. It must be clearly indicated on the proof of purchase that the credit has been given upfront to the customer as part of the lease/contractual price.

Government or education involvement

Government customers are legally identified federal, state, or local government organizations within the US. Cash back payments will be issued in the name of the government organization only. Education customers are higher education institutions and schools (K-12), both public and private, within US. Cash back payments will be issued in the name of the educational institution only.

C. Program Details

1. To take advantage of the Program, Participants must complete the online claim form (available at hp.com/go/cashin2), and attach proof of purchase for the HP products in the form of the seller's invoice, lease or contractually-placed document, including serial number(s), via scan. IMPORTANT: Each claim must be accompanied by the proof of purchase. Failure to attach will result in claim rejection. Proof of order will not be accepted. The Participant must claim by October 31, 2026, and must not send original invoices as these cannot be returned. HP must receive the claim form and supporting documents no later than midnight, Pacific Standard Time, on October 31, 2026. You must upload your proof of purchase at the time of claim submittal.
2. Once the claim form and supporting documents have been received, your proof of purchase will be reviewed and validated.
3. All incomplete/incorrect claims will be automatically rejected and must be completed and resubmitted to be processed. A claim is considered incomplete if it matches one or more of the following criteria: missing any information requested on the claim form, missing serial number of the new printer(s) purchased, missing proof of purchase documents, invoice with invalid purchase date, and/or invalid Trade-in product(s).
4. Payment will be made via check or EFT to the Participant stated as the purchaser on the proof of purchase supplied.
5. HP endeavors to process valid payment claims in eight (8) weeks from claim completion email. HP will not be liable in such cases where claims are processed outside of this timeframe. For questions regarding the status of your claim, please email: hprebatesupport@email-360insights.com.
6. The cash back will not be granted to a Participant who:
 - has not purchased or leased/contractually placed an HP product within the promotional period;
 - has not completed the claim form correctly;
 - has not supplied proof of purchase;
 - failed in any way to comply with these terms, as determined by HP's sole discretion.
7. In addition to the proof of purchase for the HP product, HP reserves the right to request from the Participant further evidence of purchase/lease/contractual placement and/or ownership (e.g., photo of the serial number label, barcodes, etc.).
8. By completing the claim registration process, the Participant confirms acceptance of these terms.
9. HP reserves the right to disqualify incomplete, altered, or illegible claims.
10. HP is not responsible or liable for any technical, hardware, software, server, website, other failures or damage of any kind to the extent that this prevents or otherwise obstructs the Participant from participating in the Program.
11. HP reserves the right to audit all cash back requests to ensure that the terms of the Program have been met, and to request additional information regarding any and all claims and supporting documents.
12. All documentation submitted for this Program becomes property of HP and will not be returned. Submission of false, incorrect, misleading, or fraudulent documentation may result in disqualification from this Program and future HP promotions and may result in the submitter being subject to legal action.
13. HP may cancel this Program where required to do so for legal or commercial reasons arising from applicable laws.
14. The decisions of HP in respect of any and all aspects of the promotion will be final and binding.
