HP Latex R530 Printer Trade-in April-June 2025 promotion



Terms

A. HP Latex R530 Printer Trade-in April-June 2025 Program structure

- Within the framework of the HP Latex R530 Printer Trade-in April-June 2025 Program, "Participants" (as defined below) may claim cashback awards by purchasing qualifying HP Latex R530 Printer (referenced in section D below) and submitting a claim in accordance with the following terms.
- The HP Latex R530 Printer April-June 2025 Program is referred to in the following terms as the "Program."

Participants

- Only end-user Customers are allowed to participate in this Program and claim and receive any cashback award.
- Resellers may submit claims on behalf of their customers.
- The Reseller must pass the full cashback amount to the Customer first. It must be clearly indicated on the invoice or lease that the credit has been given upfront to the Customer as part of the purchase or lease price.
- The company claiming and entitled to receive the cashback award is referred to in these terms as the "Participant."

Products

- The list of eligible HP Latex products can be found in section D of this document.
- Any eligible products purchased under the Program are referred to in these terms as "HP Products."

B. Program Steps and Timing

- Purchase Purchase or lease a qualifying new HP Latex R530 Printer between April 1, 2025 and June 30, 2025, and you can receive up to \$10,000 cashback allowance when you trade in your current eligible large-format printer. - Claim form—Complete and submit the online claim form (https://np.com/go/latex-r530-tradein) by July 31, 2025. Any claims received after this date will be rejected. After you submit your online claim, 360Insights will review and send a confirmation email with the claim number and instructions on next steps in the claim process. Please print and save for your records. Reference this claim number for questions relating to this promotion. You must supply the serial number and make/model of the eligible trade-in product during this claiming step.
- Proof of purchase requirements—The following documents are required:
 - a. A copy of your sales invoice(s) (or lease documents) showing eligible purchase of a new Printer(s)

- Name and address of the HP Reseller, in accordance with the statement on the letterhead

- Make, model, and serial number of Traded-in Product
- If the rebate is being passed on to end-user Customer upfront by HP Reseller, the end-user Customer invoice must show a line-item detailing the Trade-in rebate amount being deducted from printer price to arrive at net printer price

You must supply the serial number and make/model of the eligible trade-in product and purchased product during this step as part of the proof of purchase.

Keep a copy of your entire claim for your records.

Important note: The last day to submit the claim and proof of purchase is July 31, 2025. Each claim must be accompanied by proof of purchase. Failure to attach will result in claim rejection.

- Shipping trade-in product—Within one (1) business day of validation of your proof of purchase, shipping instructions, and a shipping label will be emailed to you for shipment of the Main Print Controller board. The Reseller or Customer must return the Main Print Controller board(s) for recycling in accordance with the instructions provided by the Program. The Reseller or Customer ships trade-in product to HP using their own box and the shipping label provided. The trade-in Main Print Controller board must be shipped by August 31, 2025.
- Cashback—Please allow eight (8) weeks from pick up of your trade-in Product(s) for receipt of your cashback check or electronic funds transfer (EFT). If you have not received payment after eight (8) weeks, please contact customer service via email at haprebatesupport@email-360insights.com.

Trade-in pickup and delivery

- The trade-in Product(s) must be located in the U.S.
- Shipping instructions are valid until August 31, 2025
- HP will pay usual and customary shipping charges for the Main Print Controller board from the trade-in printer(s) as part of this promotion when the designated shipping carrier is used
- You must contact the designated shipping carrier to schedule pick-up
- You agree to remove all data from your current product before shipping it. You are responsible for removing all data, including and without limitation, any personally identifiable information or protected healthcare information, from your current product before shipping it. By sending your product, you agree to release 360Insights and HP from any claim as to the data stored in such product, or in any media or data storage device included with any product that you send for recycling to 360Insights, and for the security, integrity, confidentiality, disclosure, or use of any such data. 360Insights and HP will not be responsible for securing, protecting, keeping secret, or otherwise managing any form of data or information that is stored on or otherwise contained in any product that you send to 360Insights (including any computer hard drive, ROM, CD-ROM, disk, or other storage media of any form).

Reseller involvement

- HP U.S. Authorized Large Format Production Specialist Commercial Reseller or HP U.S. Authorized Large Format Production Specialist Contractual Reseller may submit claims on behalf of their end-user customer by following the same claim process outlined above.
- HP will not compensate HP U.S. Authorized Large Format Production Specialist Commercial Reseller or HP U.S. Authorized Large Format Production Specialist Contractual Reseller for discounts that exceed the promotion cashback allowance. Leased product

This promotion is valid only in the U.S. and available for new lease agreements entered into between an HP U.S. Authorized Large Format Production Specialist Commercial Reseller or HP U.S. Authorized Large Format Production Specialist Contractual Reseller and participant if the following conditions are met:

- Proof of order will not be accepted. The seller's invoice must clearly show the Participant's name and address, part codes of the HP Product(s) purchased, the purchase price, and the date of purchase.
- The Participant must claim by July 31, 2025 and must not send original invoices as these cannot be returned. HP must receive the claim form and proof of purchase no later than midnight, Pacific, on July 31, 2025. Participant must upload proof of purchase at the time of claim submittal.
- Once the claim form and proof of purchase have been received, the invoice will be reviewed and validated. If applicable, then shipping instructions will be emailed back to the Participant.
- Participants providing an incomplete/incorrect claim form will be notified via email of the omissions and errors.
 Once rectified, claims may be resubmitted for consideration.
- Payment will be made via check or EFT to the Participant stated as the purchaser on the proof of purchase invoice supplied.

 - a. has not purchased or leased an HP Product within the promotional period
